Civil Society Dialogue Programme between Turkey and EU

In 2005, the European Commission declared their support to strong, deep and sustained dialogue between the societies in the Member States and Candidate Countries through a Communication on "Civil Society Dialogue between the EU and the Candidate Countries". With this approach, EU aims to achieve better mutual knowledge and bring citizens and different cultures, political and economic systems closer together, thus ensuring a stronger awareness of the opportunities as well as the challenges of future accessions.

Based on this development, "Civil Society Dialogue" was considered as an integral part of Turkey's EU accession negotiations. Civil Society Dialogue is highlighted as an important step in eliminating existing prejudices and misconceptions between Turkey and the EU, reinforcing social and cultural dialogue and ensuring Turkey's social integration to Europe.

The Civil Society Dialogue Programme between Turkey and EU (CSD) implemented through EU financial assistance was designed by the Directorate for European Union (former Secretariat General for European Union Affairs) in 2006 as a platform to bring together civil society organizations (CSOs) from Turkey and EU Member States around a common subject and to ensure that societies get to know each other, engage in exchange of information, and establish sustained dialogue. The programme was initiated in 2008 and it is ongoing for more than 10 years.

First Phase of the Civil Society Dialogue (2008-2009)

The first Civil Society Dialogue Programme, Strengthening Civil Society Dialogue Between Turkey and EU (CSD-I) Programme, was implemented in the scope of Turkey – EU Financial Cooperation. 119 projects were granted a total of 19,3 million euro under the themes "Towns and Municipalities", "Professional Organizations", "Universities" and "Youth Initiatives", and 238 civil society partnerships have been established between Turkey and 21 EU Member States.

Second Phase of the Civil Society Dialogue (2010-2012)

Strengthening Civil Society Dialogue Between Turkey and EU II (CSD- II) Programme was financed under the first period of the Instrument for Pre-accession Assistance (IPA I) and three grant schemes were implemented, namely, "Agriculture and Fisheries", "Culture and Art" and "Micro Grant for Civil Society". 5.3 million euro was granted to a total of 97 projects. 154 partnerships have been established among the CSOs from EU and Turkey.

Third Phase of the Civil Society Dialogue (2014-2016)

Civil Society Dialogue Between Turkey and EU III (CSD-III) Programme was supported in the second period of the Instrument for Pre-accession Assistance (IPA II) and focused on "Political Criteria" and "Media" themes. 55 projects were granted a total of 7 million euro aiming to enhance dialogue on human rights, anti-discrimination, democracy and rule of law in order to support better understanding of reforms implemented in Turkey's EU accession and their outcomes, and support dissemination of their impacts through CSO participation.

Fourth Phase of the Civil Society Dialogue (2015-2017)

Civil Society Dialogue Between Turkey and EU IV (CSD-IV) Programme was financed in IPA II period and supported a total of 80 dialogue projects with around 11 million euro under nine grant schemes, namely, "Environment", "Energy", "Protection of Health and Consumer", "Justice, Freedom and Security", "Right to Establishment and Freedom to Provide Services", "Regional Policy and Coordination of Structural Instruments", "Enterprises and Industrial Policy", "Agriculture and Fishery" and "Education".

Fifth Phase of the Civil Society Dialogue (2019- 2021)

Civil Society Dialogue Between Turkey and EU V (CSD-V) Programme is implemented in IPA II period and granted a total of 7 million euro to 40 dialogue projects to be carried out jointly by CSOs from Turkey and EU Member States/Candidate Countries.

As well as focusing on developing sustainable dialogue and cooperation, the projects are carried out in various fields such as gender equality, education, health, agriculture, food and environment.

Coordinator Beneficiaries of 32 Projects are from Turkey, 7 are from EU Member States (4 from Italy, 2 from Greece, 1 from Poland) and 1 from a potential Candidate Country, Bosnia-Herzegovina.

OBJECTIVE OF THE PROJECT

The objective of the project is to strengthen and refresh trust in the EU and its enlargement process in Turkey and Italy through a sustainable civil society dialogue and by concentrating on cross-cutting environmental and sustainable development issues.

MAIN OUTPUTS AND ACTIVITIES OF THE PROJECT

The project specifically aims to improve and support effective civil society dialogue among target groups and final beneficiaries from the EU – Italy and Brussels-based CSOs and EU institutions and Turkey in the field of environment and sustainable development. This project targets to increase bilateral exchanges and long-term cooperation between CSOs in Turkey and Italy in terms of challenges and opportunities posed by Turkey's EU accession and in terms of the EU acquis in the field of environment; to promote awareness-raising initiatives on the importance and benefits of membership of Turkey in the EU and to foster climate-friendly and sustainable development best practices. Hence, within the project 2 Opening Ceremonies in Izmir and Rome, CSD Meetings in Rome & Izmir with the participation of CSOs, private sector representatives and local municipalities and academicians, 20 Best Practice Workshops with three main topics which are: sustainable cities and sustainable development, climate action, environmental ethics and justice; Study Visits, Networking Agreement Visits and 2 environmental festivals in Izmir and Rome with the participation of 2.500 people will be organized; Monitoring Reports analyzing EU environmental acquis including horizontal legislation, EU legislation on air quality, water quality, waste management, nature protection, chemicals, noise and climate change, and the seventh environment action programme; 10 Training Modules, Advocacy and Policy Proposals Document will be prepared; 4 Animation Videos for disseminating EU best practices in the field of climate action, sustainable cities and development, environmental law and natural capital and for empowering better EU-TR civil society dialogue, against prejudices, stereotypes and misperceptions, and emphasizing the importance of Turkey's accession to the EU in terms of environmental concerns will be produced and a Best Practices Handbook on sustainable development practices will be produced, media coverage will be ensured. In order to achieve the above-mentioned outputs, following activities will be implemented:

- Bilateral Exchanges Activities (CSOs' meetings with targeted Italian and Turkish CSOs)
- Awareness-Raising Activities (Information and Communication Campaigns for target groups and final beneficiaries)
- Long-Term Cooperation Activities (Networking and follow-up activities with participating CSOs and relevant stakeholders)

OBJECTIVE OF THE PROJECT

The overall objective of the project is to improve dialogue and transfer of know-how on best practices between Turkey and EU in relation to conservation of internationally important wetlands. The project specifically aims to improve capacity of the applicant and stakeholders on monitoring and rehabilitation of wetlands through transfer of know-how and enhanced dialogue between Turkey and EU, to ensure participation of local and regional stakeholders in monitoring and rehabilitation of Gediz Delta and to identify and promote monitoring and rehabilitation actions based on the best practices in EU.

MAIN OUTPUTS AND ACTIVITIES OF THE PROJECT

Gediz Delta is one of the largest wetland complexes of whole Mediterranean Basin and one of Turkey's most extensive coastal wetlands. In parallel with the projects' objective which is mainly to conserve the internationally important wetlands there will be significant outputs. OBJECTIVE OF THE PROJECT

The objective of the project is to contribute to the sustainable dialogue between civil society institutions in Turkey and Germany by establishing a carbon awareness point. The project specially aims to create a strong bond among CSOs in Turkey and Germany, municipalities, private sector, educational institutions and other environmental stakeholders with the establishment of Zero Carbon Point, which is a concrete step towards increasing bilateral exchanges and cooperation at local, regional and national levels; and to influence public opinion on importance and benefits of integration of environmental and energy policies implemented in EU member states.

MAIN OUTPUTS AND ACTIVITIES OF THE PROJECT

The aim of Zero Carbon Point is to raise public awareness by establishing a concrete step towards environment and energy with the help of sustainable dialogue between CSOs. With the launch of Zero Carbon Point (ZCP), established as a result of dialogue on bilateral knowledge, experience and best practices at local, regional, national and international levels, a model study will have been carried out in the fields of environment and energy resources, low-carbon urbanization, green economy and sustainable development. This point will be a hub where good practice examples related with the adaptation of the components within the energy sector into daily life, on-site observation of the activities that will contribute to reducing greenhouse gas emission and efficient use of natural resources are presented, and which aims a capacity increase in waste management.

- Identifying the site where Zero Carbon Point will be installed
- Procuring technical equipment for the installation of Zero Carbon Point
- Installing the components of renewable energy systems
- Attending the workshop co-applicant organising in their own country and study visit to "Wildpoldsried" town
- Preparing training materials and visual aids and Equipping the training section
- Developing carbon and water foot printing calculation tools
- Preparing visual materials such as introduction booklets, roll-up, flags and advertising in visual and print media.

OBJECTIVE OF THE PROJECT

The objective of the project is to develop a sustainable civil society dialogue between CSOs from Turkey and Greece as well as best practice demonstration and pilot application. The project specifically aims to strengthen Joint initiatives between Turkish and Greek CSOs; Capacity building of CSOs and exposure to EU civic participation acquis; establishment of a sustainable network between Turkish and Greek CSOs; and promotion of awareness raising initiatives on importance and benefits of membership of Turkey to the EU.

MAIN OUTPUTS AND ACTIVITIES OF THE PROJECT

Archaeological sites host important, often endemic and/or rare, species of local flora, which usually survive there because of the relative protection offered in relation to the surrounding, heavily developed areas. Such sites include Side in Antalya, and the Acropolis Hill of Athens, each hosting an endemic species. There is a very special and important natural heritage of the archaeological sites of Acropolis and Side as an opportunity for civil society dialogue between the two countries and the symbolism of brotherhood. In this sense this projects' outputs will target stakeholder cooperation towards sustainable development; improved scientific and administrative capacities of local CSOs; improved conservation of local environment; improved citizen awareness and knowledge; improved stakeholder participation in protection of the environment and cultural heritage; development of common methodologies for monitoring of threatened local flora species in archaeological sites; recommendations for management practices in archaeological sites to enhance conservation of local flora.

In order to achieve the above-mentioned outputs, following activities will be implemented:

- Comparative study of applied policies and methodologies for management of local flora in archaeological sites
- Elaboration of common methodologies for the monitoring of flora species in archaeological sites
- Introduction and application of common environmental policy codes and protocols
- Establishment of a network of all stakeholders involved in the management, preservation and conservation of archaeological sites
- Technical guides for the classification of flora species in archaeological sites
- "Virtual Garden" informative application
- Design and production of environmental education material
- Training sessions for archaeologists, tourist guides and other related stakeholders

OBJECTIVE OF THE PROJECT

The objective of the project is to support the specific population group of mothers of 6-14 age group children in Batman, as pilot application, to adopt healthy lifestyles, and to develop guidelines for improved networking and knowledge sharing among TIHF's members to push for policy change for intervening, pre-empt policies, and spreading awareness on the problem.
